Introduction

This document describes how to upload photos and images in the Aivre system.

Note: Items highlighted in **grey** are on the Aivre roadmap. We will update this document when the feature has been added to the Aivre system.

Placement of Images

Be sure to upload each image to the appropriate section of the URAR. For example:

- Put dwelling front, side, and rear views in **Dwelling Exterior**, not in **Subject Property**.
- Put pictures of rooms in **Unit Interior**, not in **Subject Property**.

Photo Size

Images must be sized properly to display the content on the report PDF. The Aivre field *Photo Size* enables you to do this.

- Big Photo: Displays approximately “letter size”. Examples: Maps, Sketch
- Graph: Takes up the entire width of the page, up to 3 per page. Example: Graphs in the **Market** section
- Photo: Displays up to 8 per page. This is the default size for all other photos.

Aivre defaults some exhibits to a certain size, but the appraiser can change the *Photo Size*. For example, if you were adding a maintenance agreement or plat map in the **Site** section, or a Cost Approach worksheet in the **Cost Approach** section, you would select ‘Big Photo’ for the *Photo Size*.

- If necessary to ensure readability, you should split documents and upload them as separate images. Example: Sketch, Market Exhibits.

Predefined Captions

Aivre automatically populates predefined captions as specified in the **Photo or Image (Predefined Caption or Gray Bar)** column in the tables below.

- Do not enter duplicative or conflicting information into the additional caption.
- You might not always need an additional caption. Use the **Is there an Additional Caption** column in the tables below for guidance.

View All Report Images

On the Right Navigation bar, select the *Report Images* icon to view all the images on a report in one place.
